| <p><b>Notes for Completion</b></p> | <p>Form C5 1-6 should be completed by the person(s) organising the activity, and should be signed by the person responsible to Scouts Australia for the staging of the activity.</p> <p>All Youth Program Leaders should submit a proposed program for Camps or overnight Activities with the Form C5 for the approving Leader to assess whether the proposed activity is suitable for the Youth Members involved and that the activity conforms with prescribed safety and supervision standards.</p> <p>The approving Leader will then consider the details provided and give approval if confident that the activity is suitable.</p> <p>Youth Members who are conducting activities must prepare and sign for their own activities by completing Part 1 Section 6. This form should then be given to their Leader, with the Program and other details to assess whether all aspects of the activity are suitable and safe; and the Youth Member has the training and responsibility to conduct the activity. This Leader will countersign after consideration and pass on to the Formation Leader for approval.</p> <p>Section 3 Activity Site - A full description of the activity site(s), the location, or route details, with overnight stops must be given so that participants may be readily located in the event of an emergency. If space on the form is insufficient, attach a separate list and/or map. | <p><b>Activity Approval</b></p>    | <p>Details of the proposed activity should be checked by the Approving Leader to ensure that the activity is a proper Scouting activity; that it is correctly planned in accordance with the rules of Scouts Australia (P&amp;R), Queensland Branch Scouting Instructions (QBSI), State and Local Government Regulations; that adequate leader and resource personnel are available; that qualified technical specialists are available where necessary; and that all specified safety measures have been taken.</p> <p>Form C5 should be prepared sufficiently far in advance of the proposed activity, and be dispatched to reach the Approving Leader two weeks in advance of a Mob/Pack holiday, and one week in advance of other activities.</p> <p>The Approving Leader will be for:-</p> <ul style="list-style-type: none"> <li>Activities/Camps within the Group - Group Leader (Where a Group has a Group Leader in Training or a Leader in Charge then approval will occur by the District Commissioner.)</li> <li>Group Family Camps, District Training Camps and Activities - District Commissioner (if no District Commissioner then Regional Commissioner.)</li> <li>Region Activities/Camps - Region Commissioner.</li> <li>Branch Activities/Events - Chief Commissioner.</li> </ul>  |                                    |                      |                 |                  |                |                                    |               |              |                    |          |                 |  |
